Payment Plan Options

Plan A: Annual Payment Plan (lump-sum tuition payment)

TERMS

1. No refund of the application or re-enrollment fee can be made under any circumstances.
2. All enrollments after May 1 require fees to be paid at the time of enrollment and monthly tuition payments must be paid in full by February.
3. I understand that changes to the enrolled schedule may be subject to administrative change fees.
4. I recognize that Addlestone Hebrew Academy incurs fixed obligations based on its expected enrollment, and therefore, I agree to pay the following if the enrollment agreement is cancelled:
 - a. If enrollment agreement is cancelled between June 1 and August 15, I will be obligated to pay 20% of tuition charges.
 - b. If enrollment agreement is canceled between August 16 and November 1, I will be obligated to pay 80% of tuition charges. Payment dates will remain according to the original contract payment schedule. If payments are not made according to that schedule, the obligation for the entire tuition and fees will be reinstated and referred to a collection agency.
 - c. If enrollment agreement is canceled after November 1, I will be unconditionally obligated to pay 100% of all tuition and fees for the entire academic year according to the original contract payment schedule. My obligation is notwithstanding the subsequent absence, withdrawal, or dismissal from Addlestone Hebrew Academy of the student named on this contract. If payments are not made according to the original payment schedule, the obligation will be referred to a collection agency.
5. Transcripts and grade reports will be withheld for students with outstanding balances.
6. **ALL REQUESTS FOR CANCELLATION OF ENROLLMENT MUST BE SUBMITTED IN WRITING.**
7. I understand that students may be required to withdraw from Addlestone Hebrew Academy because of disregard for major rules and regulations, violation of the law, personal maladjustment, prolonged academic deficiency, or lack of parental cooperation.
8. If legal action becomes necessary due to default of payment, I will pay the Academy's reasonable attorney fees and all other fees associated with this collection.
